

Chapter 10: The Civil Rights Movement, 1960-1971 Internet Activity

In this lesson, you will explore websites to learn about civil rights challenges in Mississippi and the south as a result of "Jim Crow" laws.

Instructions: Click the links below and use the information from the websites to complete each item.

Throughout the 1890s and into the 20th century, laws and ordinances called Jim Crow laws were enacted which called for *segregation*. Even before the passage of these laws, customs and intimidation had already created a system of white superiority in Mississippi and other southern states. Jim Crow laws served to make the practice of segregation legal.
